


21 – 173 Resolved to approve the minutes of May 4, 2021 as circulated. All in favour, Motion Carried.

DEFERRED CORRESPONDENCE

REZONING REQUEST – ST. CECILIA STREET

The Manager explained the procedure for changing zoning to Council.





Much discussion took place and a vote was taken – 3 Councillors voted to change the zoning to Mixed Development and 1 Councillor voted not to change the zoning to Mixed Development.

LAURENTIAN PARK – PETITION

The Manager advised that she visited the tennis court today with Pat Cusick. She advised that the lines on the tennis court can be moved back and still accommodate the skate board park. She showed Council pictures that she took today while on site.

Discussion took place and it was agreed to engage the person who painted the lines on the court originally to change the lines.



The consensus was to file this correspondence.


RV PARK

IRON SPRINGS ROAD – WATERING BY CFI


It was noted that the Iron Springs Committee would be approaching CFI to request watering of the Iron Springs road.
